TUITION & FEE CONTRACT

1. _____ Tuition shall be paid monthly on or before the 10th of each month (Late Fee of \$10 due if paid after the 10th)
2. _____ Tuition is due regardless of attendance. If a child has missed a class due to illness, make-up classes are encouraged. Check with the office for day & time. You may not skip a month of dance and then start back with classes and payments without notifying the office first. If not notified in advance, you will be responsible for paying tuition for the missed month.
3. _____ Recital Fees: \$140 for first student & \$120 for each additional student in the family. Recital Fee includes one costume. There will be a \$60 fee for each additional costume if a student is in additional classes.
4. _____ Recital Fee is due with measurements January 8th-13th, 2024. A \$10 late fee will be charged after this date. Students will not be permitted to participate in the recital if measurements and payments have not been submitted.
5. _____ ALL TUITION AND FEES ARE NON-REFUNDABLE.
6. _____ All accounts must be paid in full in order for your child to participate in annual performances.
7. _____ \$35.00 will be charged on all returned checks.
8. _____ Notification of withdrawal must be submitted in writing to the office (not teacher) before the 1st of the month.

I initial each item of the terms of registration to show that I have read the tuition fee contract and understand the monetary obligations associated with my child(ren)s class(es) and accept responsibility to pay. I understand that my child(ren) will be participating in an active program and accept the risks. I have given permission for Alabama River Region Ballet to take and publish photos of me or my child. I agree that I will not hold Alabama River Region Ballet or any Alabama River Region Ballet faculty member or employee liable for any injury sustained or illness contracted while I or my child is a student at Alabama River Region Ballet. I exempt and release Alabama River Region Ballet and its agents from any and all liability claims, demands or causes of action whatsoever from any damage, loss or injury to the student, parent, guardian, family member or personal property which may arise out of, or in connection with participation in any Alabama River Region Ballet activities.
